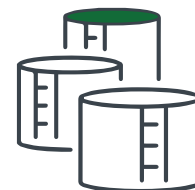
- + Production is operated efficiently on an area of 3 hectares with an output of 24,000 tons of oil/year and 15,000 tons of plastic beads/ year.

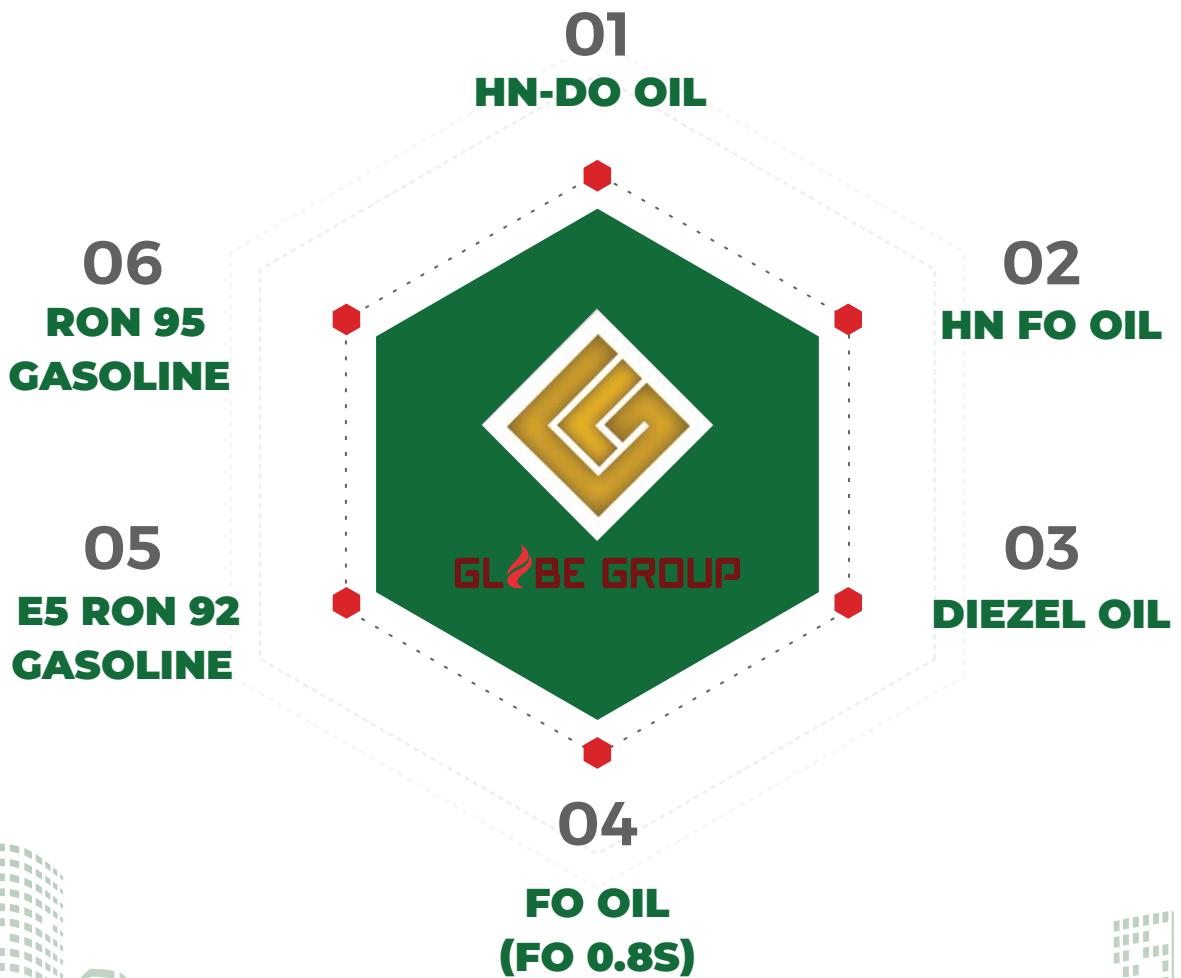

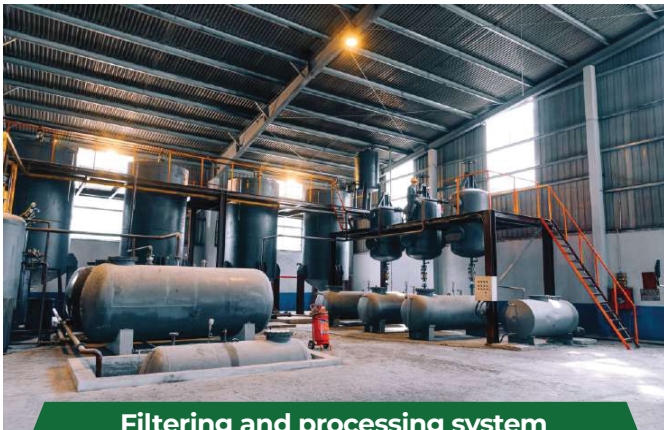

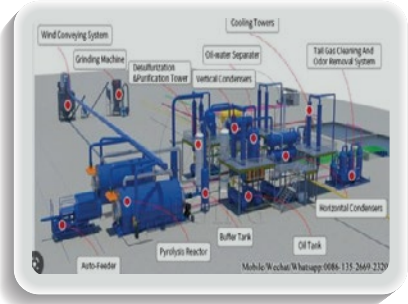
